

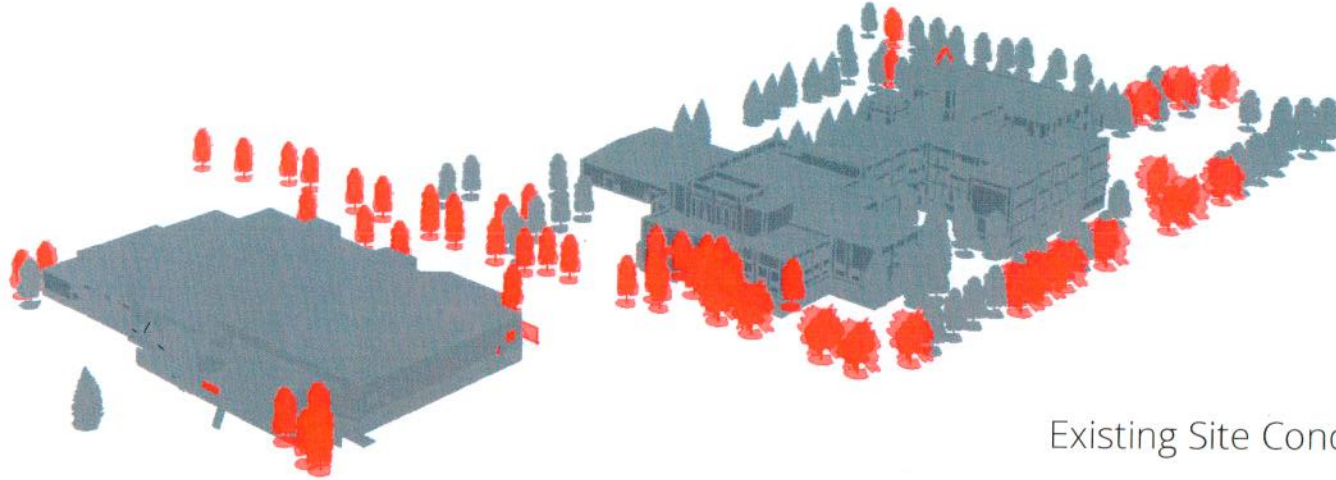

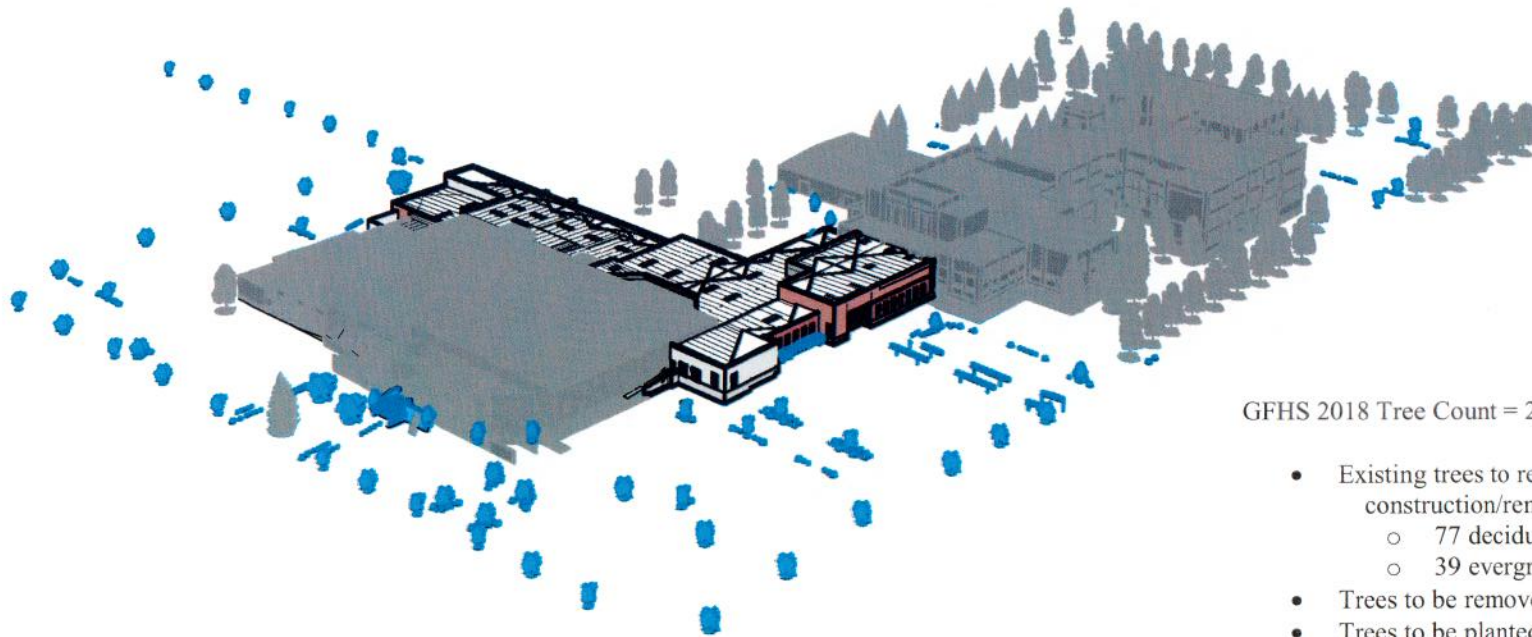

Existing Site Conditions

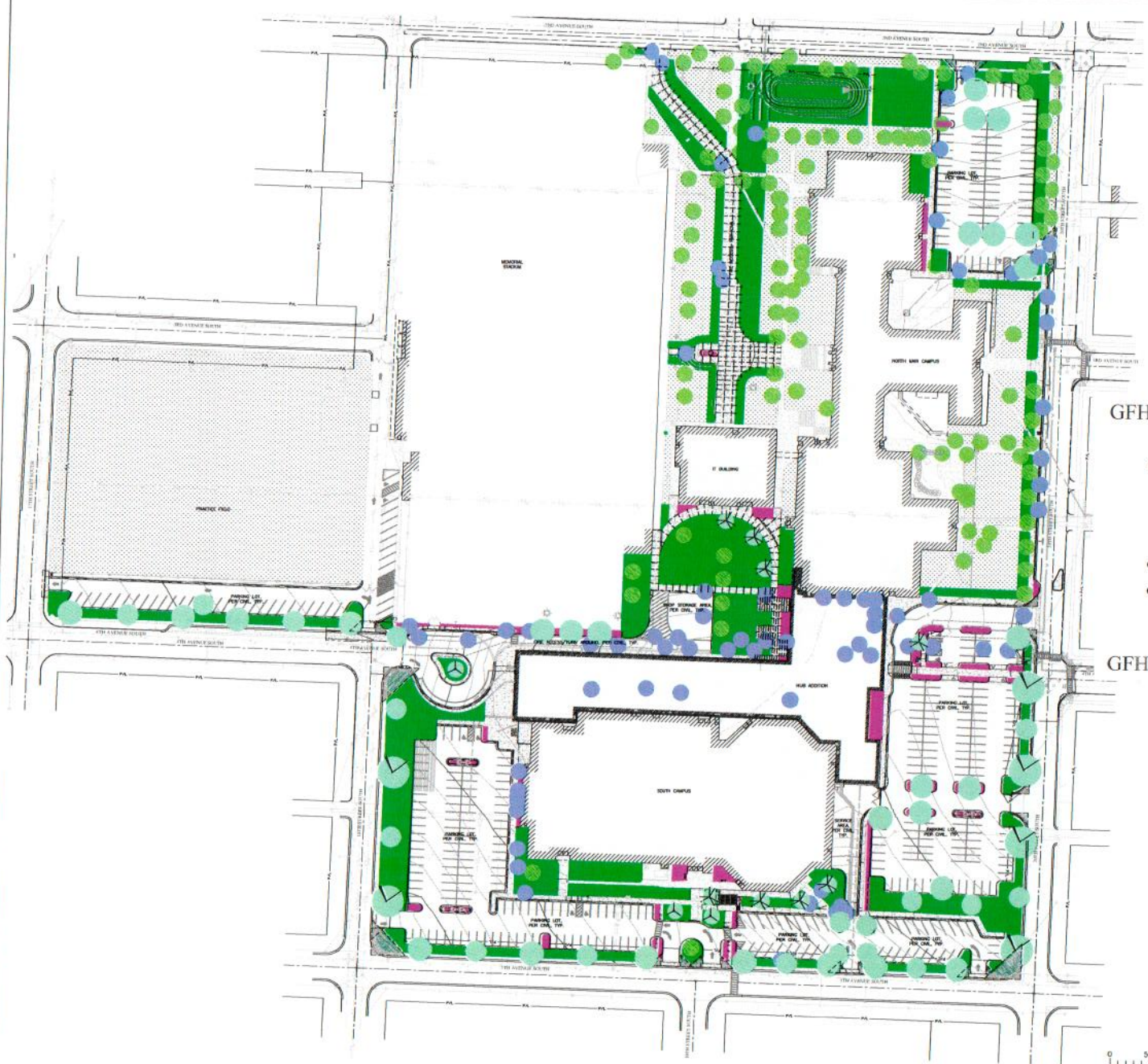


GFHS 2018 Tree Count = 262

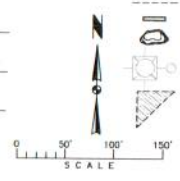
